

## PERSONAL GUARANTEE FOR AGENTS

The undersigned (hereinafter GUARANTOR), in consideration of the execution of the Service Agreement between your employer \_\_\_\_\_ (hereinafter CLIENT) and **CAL COAST CREDIT REPORTS**, (hereinafter CCCR), hereby unconditionally guarantees and promises to pay any and all debts, obligations, and liabilities (including attorney fees and costs of collection) incurred under GUARANTOR'S own account. Moreover, GUARANTOR agrees to be responsible for all activity and charges under his or her own account, even if incurred by any other person, if fraudulently ran, or unauthorized by the GUARANTOR. It is imperative that GUARANTOR does not give out his or her User Name or Password to others. It is GUARANTOR'S sole responsibility to protect and maintain the security of his or her own account information. In the event GUARANTOR'S account information is compromised, GUARANTOR must notify CCCR immediately to prevent fraudulent transactions. Even in such an event, GUARANTOR agrees to be responsible for all charges that incurred under his or her own account.

This is a continuing guarantee, which applies to any modification of the service agreement. GUARANTOR waives notice of acceptance of this Guarantee, notice of any renewal, or extension of the Service Agreement.

This Personal Guarantee and the rights and obligations of the parties shall be governed by California law. GUARANTOR hereby consents to jurisdiction by, and waives any objection to the exercise of jurisdiction by, the courts in the County of San Francisco, California. In the event an action is brought to enforce performance of this Agreement, the prevailing party shall recover reasonable attorney's fees and court costs. Moreover, GUARANTOR authorizes CCCR to obtain a credit report on GUARANTOR prior to approval of account or at any time for collection purposes. Furthermore, GUARANTOR authorizes CCCR to charge the Credit Card below for any outstanding balances on his or her own account each month.
